The age of the participant of the competition is determined by the date of birth in the identity document of the athlete.

The weight category in which an athlete can perform is determined by the coach and doctor, about which the medical and control mark is recorded in the team application.

CONDITIONS OF REGISTRATION OF ATHLETES

Each participant at the time of passing the mandate commission must have the following documents:

- Entry Form

The original application is provided to the mandate commission of judges, signed and certified by the seal of the head of the sports organization, and the medical dispensary with the signature of the doctor.

BEFORE 10/11/2021.

- Passport or other identity document with a photo.
- Participant card issued at the registration of the mandate commission.
- Sports insurance policy valid for the duration of the competition.

** in case of non-submission or non-compliance of the provided policy with the requirements of the standard, it is possible to issue a policy by the agent of the insurance company during registration at the mandate commission. The cost of a sports insurance policy will be 10 euros.*

- Application for consent to participate in competitions, for minor athletes the application is filled out by parents.

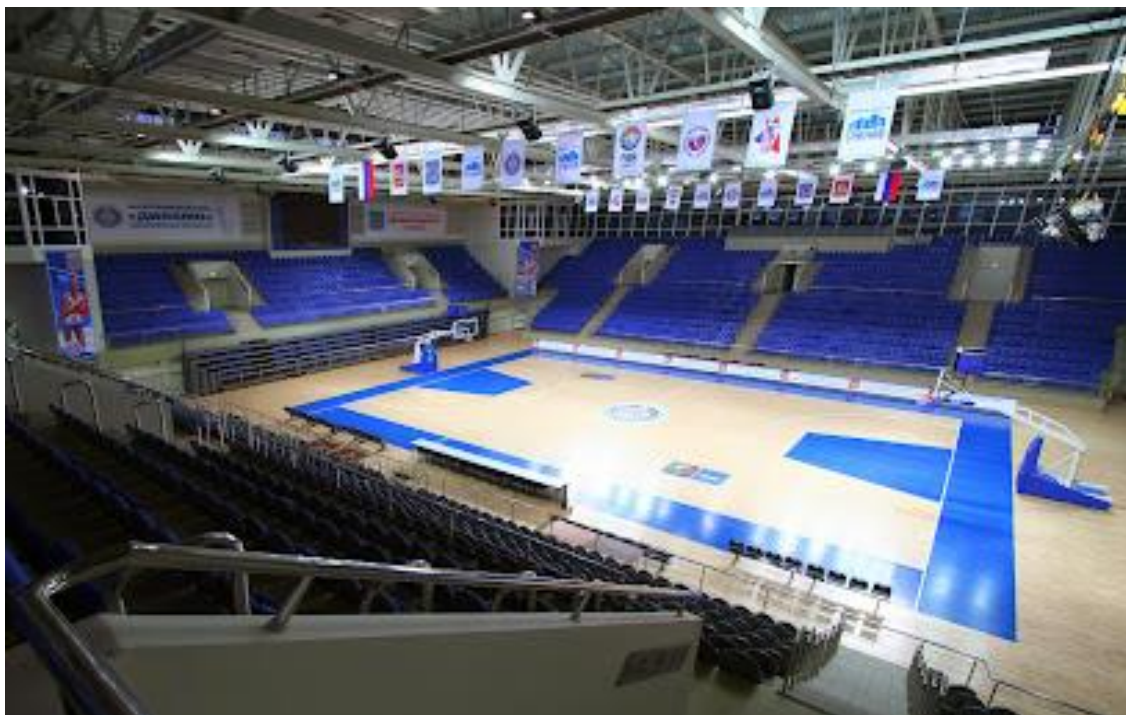
! Teams that arrived at the tournament without officially certified applications or documents that do not meet the requirements are categorically not allowed to compete.



FINANCIAL CONDITIONS

The entry fee will have to be paid **ONLY** in cash on spot at the moment of the accreditation.

ENTRY FEE: **30 Euro** (in each section, for each weight category).



IMPORTANT NOTE

If you need to receive individual invitations, you need to send an e-mail list of the delegation, indicating the name, surname, gender, date of birth and status of each participant.

Weigh in will be held at the registration before the beginning of the fights.

All participants should have medical documents and insurance.

"Ykhino" - 9,8 km

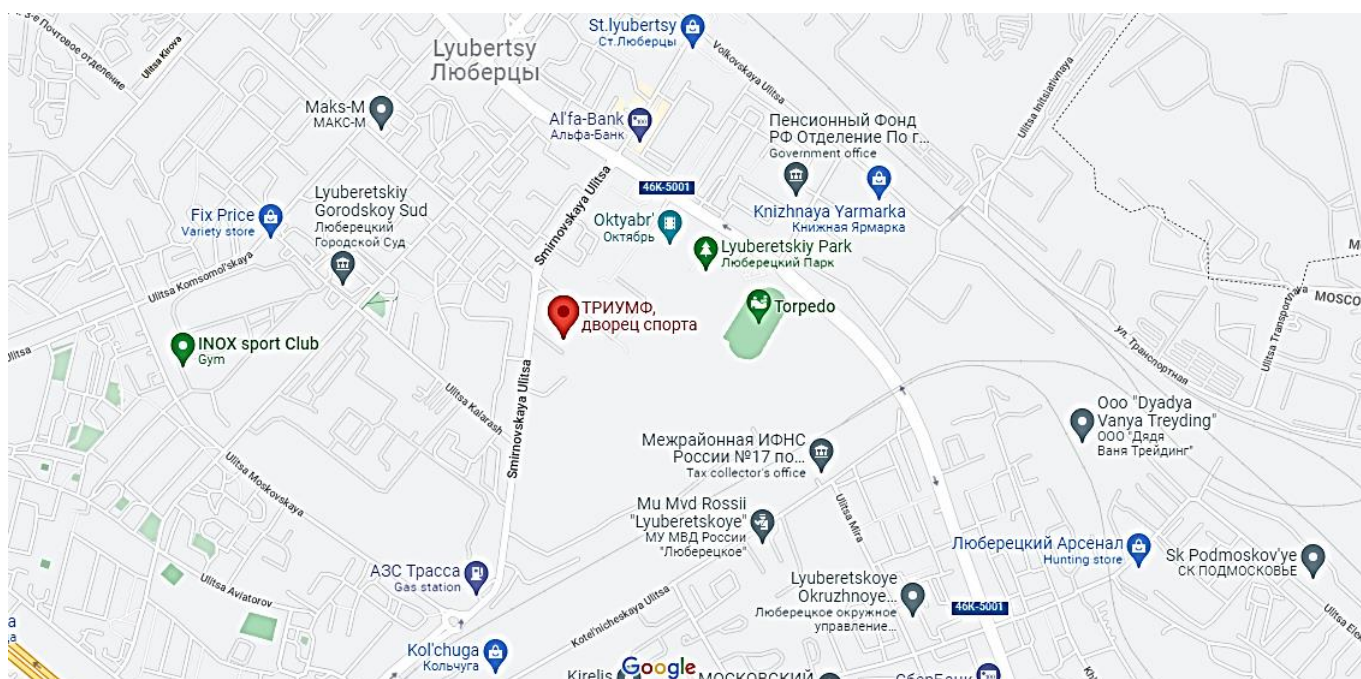
From Sheremetyevo Airport: by Aeroexpress to the station «Begovaya», transfer to the metro station "Begovaya", by metro to the station "Lermontovsky Prospekt", then by bus to the remains of the "Gastronome".

From Vnukovo Airport: by Aeroexpress to the station «Kievsky railway», transfer to the ring metro station «Киевская», by metro to the station «Taganskaya», transition from the circle line to the station «Taganskaya» Tagansko-Krasnopresnenskoj liny (boarding the first car), to the station "Lermontovsky Prospekt", then by bus to the remains of the "Gastronome"

From Domodedovo Airport: by Aeroexpress to the station «Verkhniye Kotly», transfer to the metro station «Verkhniye Kotly» (boarding the last car), by metro to the station «Nizhegorodskaya», transfer to the station «Kosino» to the station "Lermontovsky Prospekt", then by bus to the remains of the "Gastronome".
